ENVIRONMENTAL PROTECTION ENGLAND

The Environmental Protection (Restriction on use of lead shot) (England)

Summary of the regulations

In England from 1st September 1999, it is illegal to use lead shot for the purpose of shooting with a shotgun: -

- a) On or over any area below the high-water mark of ordinary spring tides.
- b) On or over any of the sites of Special Scientific Interest listed in the Regulations. c) Any duck, goose, coot, moorhen, common snipe or golden plover Anywhere.

The primary enforcers of these Regulations are the Police. They may enter premises (land, vehicle or vessel but not residential premises) at any reasonable time, with a warrant, if necessary, to determine whether the Regulations are being, or have been, complied with. They May take away any birds or samples of cartridges and have them analysed. Any person who causes or permits another person to contravene the Regulations is guilty of an offence. Conviction for any offence under these Regulations carries a fine up to £1000

I have read & understand the Regulations restricting the use of lead shot and will NOT use

any lead shot in contravention of the Regulations, or of any other restrictions that are applied to my shooting.

I also agree that in the event of any legal prosecution involving me regarding contravention of these Regulations, NO blame whatsoever shall be attached to the South Solway Wildfowlers Association or its Officers
